INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA CLIENTS, SUPPLIERS, PARTNERS

pursuant to EU Regulation 2016/679

With regard to the processing of the personal data provided, the following information is given:

1. Data Controller

The Data Controller is the company Società Agricola Casetto Aldo Brancher & C. s.s. Via Monte Noal e Pigno, 8, 37011 Cisano di Bardolino – VERONA (Italy), VAT No.: 03128020231 – Tax Code: 03290990260 (hereinafter referred to as the "Company").

2. Type of data processed, purpose and legal basis of processing

The following personal data are collected and processed: common personal data (first name, last name, personal details, role within the company, contact details, email address, mobile phone number) relating to supplier/customer companies or entities and to the employees, collaborators and subcontractors of suppliers/customers, where communicated by them, for: a) pre-contractual purposes and performance of the contractual relationship; b) administrative, accounting, tax and legal obligations connected with invoicing and management of the contractual relationship.

The legal basis for the processing of data is therefore: performance of contractual obligations for the purposes under point a); compliance with legal obligations for the purposes under point b).

3. Communication of data to third parties - Data recipients

For the purposes indicated above, the Company may communicate the processed data to: i) internal company personnel authorized to process data and system administrators in the event of IT interventions; ii) external parties belonging to the following categories: external consultants and their appointees, service companies, banks, insurance companies and credit institutions, supervisory and control authorities.

4. Transfer of data to Third Countries

The processed data may be transferred by the Data Controller to Third Countries for the purposes indicated above. However, in the event of data transfers to such countries, the transfer will take place in compliance with the legislation in force from time to time on the transfer of data to third countries pursuant to Articles 44 et seq. of GDPR 2016/679.

5. Processing methods, retention period and data storage criteria

Data will be processed in paper and digital format. Data will be processed by the Data Controller for the period necessary to achieve the above purposes and, thereafter, for the additional statutory limitation period required by law for the retention of contracts and administrative data and/or for legal defense purposes (ten years from the last use and/or event interrupting the limitation period).

6. Provision of data

The provision of data is mandatory for the performance of the contractual relationship and for legal purposes. Failure to provide the data will result in the impossibility of pursuing the above purposes.

7. Rights of the data subject, withdrawal of consent and complaint to the Supervisory Authority

Where the legal requirements are met, the data subject has the right at any time to request access to personal data, rectification, erasure, restriction of processing, to object to processing and to exercise the right to data portability.

In any case, the data subject has the right to withdraw any consent given to data processing at any time, without affecting the lawfulness of processing based on consent given prior to withdrawal.

In the event of an alleged violation, where applicable, the data subject also has the right to lodge a complaint with a supervisory authority in the EU Member State where they habitually reside, work or where the alleged violation occurred.

8. Profiling and automated decision-making processes

Processing is not carried out through automated decision-making processes (e.g. profiling).
